CEEC ACTIVITIES

OUR MEETINGS

On 20 and 21 October, the CEEC held its 101st General Meeting in Madrid. Pedro José HUERTA and Javier POVEDA, our Spanish hosts, warmly welcomed our group despite the rainy weather. During their stay, the members of the CEEC were received by Mgr Alfonso CARRASCO and Mgr José COBO, who celebrated Mass on Friday and Saturday morning..



During the round-table discussion of the meeting, the members had the opportunity to share information and discuss the latest developments in their countries, with a particular focus on the situation of Catholic schools in Ukraine. The floor was also given to Hervé LECOMTE, Secretary General of the International Office of Catholic Education (OIEC), Michel BERTET, member of the permanent representatives of the OIEC in international bodies such as the Council of Europe, and Pascal LEROY, head of the OIEC's 'Planet Fraternity' project.

A special guest was Father Youssef NASR, Secretary General of Catholic Schools in Lebanon and Regional Secretary of the OIEC Middle East North Africa (MENA) region. He spoke at length about the "Mediterranean Encounters", which were marked by the presence of Pope Francis in Marseille last September.

The training system of Austrian Catholic schools was presented as part of the CEEC's work on the initial and in-service training of teachers and heads of Catholic schools in Europe. This work is currently coming to a close and a document summarising the results of the survey and the presentations organised since 2019 will be published in April 2024 at the General Assembly in Bergen (Norway). On this occasion, a new theme will be launched.

At the same time, the General Assembly meeting saw the election of the Executive Board for a 4-year term. The associations elected are as follows

- The Nederlandse Katholieke Schoolraad (NKS) represented on the Executive Board by Titus FRANKEMÖLLE.
- The Association of Management of Catholic Secondary Schools (AMCSS) & Joint Managerial Body (JMB) (AMCSS) represented on the Executive Board by Paul MEANY.
- Escuelas Católicas represented on the Executive Board by Pedro José HUERTA NUÑO.
- The Commission for Education of the Slovenian Bishops' Conference represented on the Executive Board by Marko WEILGUNY.
- The General Secretariat for Catholic Education in France (SGEC) represented on the Executive Board by Marie-Caroline HAMON-VINET.
- The Austrian Interdiocesan Office for Catholic Education, represented on the Executive Board by Marie-Theres IGREC.

Secondly, the members elected Paul MEANY, from Catholic Education in Ireland, as President of the association.

Finally, the General Assembly applauded these members for their appointments and warmly congratulated José Maria ALVIRA on his departure. He was thanked for his excellent work as President and for having represented Spanish Catholic schools within the CEEC for 10 years. Thank you for the many years of collaboration!

THE EXECUTIVE BOARD IS GROWING: TWO NEW REPRESENTATIVES

Marie-Theres IGREC is interdiocesan delegate for Catholic schools and theological consultant at the Austrian office for Catholic Education. She studied law and theology at the University of Vienna and the University of Zagreb and holds a doctoral degree in fundamental theology. She worked as teacher of religion and lecturer at the department for Systematic Theology and professor at the Teacher Training University in Vienna.

Marie-Caroline HAMONT-VINET holds a double master's degree in law and human resources. During a 3-year expatriation to the United States, she worked as a HR manager for an association offering French language courses to young expatriates. When she returned to France in 2016, she naturally joined the French Catholic Education Association in Nantes as General Delegate. Since 2021, she has been working with the General Secretariat of Catholic Education (SGEC) to support the implementation of the 'International Openness' label throughout France, in addition to her work in Nantes.

AN INTERVIEW WITH THE NEW PRESIDENT OF THE CEEC, PAUL MEANY

Hi Paul, congratulations on your new position. How are you feeling? Are you happy, anxious, confident? What is your state of mind?

I am honoured to have been elected as President of the CEEC for the next four years, and I look forward to working with my CEEC colleagues, as well as with the leaders of our partner organisations, to further the project of Catholic education in an increasingly secularised Europe.

Can you tell us more about your background and experience in Catholic education?

Educated in Dublin by the Marist Brothers, I became a teacher in 1973 in Marian College after I finished my Science degree. I became the first lay-Principal of the school in 1988 and soon became actively involved the Association of Management of Catholic Secondary Schools (AMCSS) becoming President from 2004 to 2006. At that time I became the Irish representative on the CEEC, joining the Executive Board and for the last eight years I have been Treasurer of the CEEC. In Ireland, I am currently the Chairperson of the Association of Patrons and Trustees of Catholic Schools (APTCS), a Director of the Catholic Education Partnership (CEP) and a Director of the Le Chéile Education Trust.

In your opinion, what are the most important challenges that Catholic education is facing at the present time?

In my view, Catholic education occupies a vital position in the Europe of today. Our emphasis on the search for meaning, and our position between the family, the State and the market, means that the education provided in our schools will never be simply to further the ends of the State, nor sim-

ply to meet the needs of the market, but will continue to be an informed examination of the place of the individual within his or her community and society. We face the challenge of maintaining our Catholic identity whilst being open and welcoming to people of all faiths and none. To achieve this we rely on our teachers and one of our greatest challenges is to identify future teachers and leaders who are committed to the message of the Gospel.

As President of CEEC, how will your position and/or the Association help to address these challenges?

During my Presidency, CEEC will continue to explain the value, rationale and legal basis for Catholic education, support our member organisations in their relationships with their Governments, and form an active collaborative network sharing the best of Catholic education.

WAR IN UKRAINE: BACK TO SCHOOL AND STATEMENT TO HCHR

At the beginning of the school year, Father Petro MAIBA, representative of Ukrainian Catholic schools at the CEEC and Head of the Education Department of the Ukrainian Greek Catholic Church, gave an interview to VaticanNews. It was an opportunity to find out more about the situation in Ukrainian schools and to put it into perspective with other schools in Europe. On 25 September, Philippe RICHARD, Permanent Representative of the OIEC, delivered an oral statement on Ukraine at the 54th session of the High Council on Human Rights in Geneva. The text of this statement was written by Father Petro MAYBA and made available in our newsletter.

Dear Mr President

Ukrainian schoolchildren have completed their second school year in the context of a large-scale invasion by Russia. The education system is adapting: schools are building shelters and buying generators, parents are preparing "evacuation bags" for children in case of an air raid during lessons, and extra lessons on mine safety are being introduced into the curriculum.

At present, the Ukrainian education sector still needs 3,000 shelters, at a total cost of over a billion dollars.

This means that some children will not be able to return to full-time offline education this year. At the same time, three out of four Ukrainian schoolchildren do not have a personal laptop to learn online. This means that these children will not be able to study at all, or will have very limited access to educational opportunities. As a result of the war, three quarters of Ukrainian children (75%) now show symptoms of psychological trauma. This means an increased demand for inclusive education.

The destruction of schools and critical infrastructure, and the death and emigration of teachers and pupils, are just the tip of the iceberg when it comes to violations of international and humanitarian law in Ukraine. Every teacher who has been forced to flee abroad represents one less mentor for a pupil. Every air raid siren increases a child's risk of developing anxiety and mental disorders. Every bomb that falls on a Ukrainian school doesn't only damage the building, it also damages the quality of Ukrainian education.

We must understand that all this represents one of the most important indirect crimes of this war: Russia is stealing Ukrainian children's right to education. And with it, the right to a full and quality future.
